Applications will be received from the individuals by hand on the following dates between **9:00 A.M. and 09:30 A.M. at National Institute of Nutrition, Hyderabad for Walk-in-Written Test/ Interview. The candidate will not be allowed to enter the Institute after 09:30 A.M. under any circumstances.** The Candidates may download the application form from www.ninindia.org/ www.icmr.nic.in. If the candidates are not able to download the application form, it will be provided to the candidates at the venue on the date of Walk-in-Written Test/ Interview.

Selection Procedure: Interview will be conducted to the eligible candidates after verification of the certificates. However, if more number of candidates are found eligible for the post advertised, Written Test/ Skill Test may also be conducted on the same day for final round of Interview.
