Candidates possessing prescribed essential qualifications will only be considered for short-listing. **Selection of candidates shall be provisional subject to verification of original certificates.** No document other than pass certificate or provisional pass certificate will be accepted as proof of completion of a course. The date of interview shall be the crucial date for determining age and educational qualification. HRA shall be paid at the rate determined by ICAR to Senior Research Fellow, in case no Government accommodation is allotted. No TA/DA will be paid for attending the interview.
