TISS is a centrally funded public university which operates from four campuses located in Mumbai and Tuljapur in Maharashtra, Guwahati and Hyderabad; and has expanded its education, training, research and outreach activities in several other states as well. TISS's off-campus at Hyderabad is the knowledge partner of the State Resource Cell for Women (SRCW) Project with the Department of Women and Child Development, Government of Telangana to provide integrated support and assistance to women.

A Project Management Unit (PMU) was set up for implementation of the SRCW, is located in the Directorate, Women Development and Child Welfare, Government of Telangana, Hyderabad. Applications are invited from highly committed and motivated individuals with experience of working on women's issues to manage the Project Management Unit (PMU). This is an ongoing project; this position is to be filled initially up to September-2022 and may be extended further based on the performance of the candidates and continued relevance of the position to the project.

Research Officer: Post (1) to be placed at PMU-SRCW, WCD, Hyderabad, TS.

Eligibility Criteria:

Essential

- Master's Degree in Social Work/Economics/Women's Studies/Law/Governance/any other related field.
- Minimum experience of 2 years in Research field.
- Must have computer knowledge and ability to work in various MS Office, data analysis packages like SPSS, STATA etc.

Desirable

- Previous experience of working with the government.
- Can Speak English and Telugu fluently and possess good writing skills in English.

General Condition

- Involves extensive travel within the state.
- Age of candidate preferably between 30-45 years.

Remuneration: Consolidated payment of Rs. 26,250/- per month.

Roles and Responsibilities

- Collate and document information, gender disaggregated data relating to various sectoral areas like livelihoods, health, education etc., particularly with regard to women
- Undertake empirical as well as desk-based studies to review implementation of gender sensitive health policies and programmes.
- Assist specialist Gender to undertake research studies to assist in framing policies and programmes under the convergence mandate of the Mission
- Undertake any other activity as may be required to further the aims and objectives of SRCW.
