1. Place of posting is ICAR - IIOR, Hyderabad. Work place may be at any Research Farm of IIOR, Hyd. (Rajendranagar /Narkhoda /ICRISAT, Hyderabad).
2. The above position is purely temporary and co-terminus with the Project and also subject to the satisfactory performance of the incumbent. There is no provision of re engagement after termination of the project. The selected candidate shall not claim for regular appointment at this Institute.
